- 1. Unique to the 'Customer Asset Services' program are the following additional terms and conditions (And will not invalidate any of the Standard RentalTec T&C's Which remain 100% applicable):
- a. A diagnostic fee of €200 is applicable and will always be charged if the item is beyond economical repair, or if the customer rejects the quote for repair, service, maintenance, or calibration. This fee is not added to the cost of the repair, service, maintenance, or calibration if the customer approves the quoted service or if it is Covered Under Rentaltec Warranty.
- b. Minimum TAT of 20 working days, subject to the outcome of the evaluation/diagnostic, and delays due to quote approval on behalf of the customer.
- c. Warranty of 6 months on the repair, if the same issue reoccurs and no extra damage is sustained. This will be subject to a case by case investigation and approval by the lab.
- d. If RentalTec has items from the customer in its possession (calibrations, repairs, inspection, etc.) and these items are to be forwarded or transported for any reason, the customer shall bear the risk of loss, theft, damage, perishing or deterioration during transport. Any CAS order Shipments performed by Rentaltec NV are shipped under the CPT incoterm. the goods are considered to be delivered when the goods have been handed over to the first or main carrier, so that the risk transfers to the Customer upon handing goods over to that carrier at the place of shipment in the country of Export.
